3. Candidate must be first or corresponding author of the research article.
4. Research article with highest NAAS rating will be selected for the award.
5. In case, two articles are with same NAAS rating, then article with highest citation as per the google scholar till 15th June, will be selected for the award.
6. SPFCA reserves the rights for the final selection of the award.
